Pan-Florida Challenge Cancer Ride Brings Riders Of All Levels Together To Fight Deadly Disease *Powerful Stories Behind Why Riders Take Part* Submitted By Josh Milton

Cancer survivor, friend lost to cancer, cancer researcher. These are just some of the people involved with the annual Pan-Florida Challenge Cancer Ride (PFC) taking place in Naples and Tampa on March 25-26. PFC funds ground-breaking research studying the linkages between hunger and cancer at Moffitt Cancer Center. PFC also provides nutritious meals to underprivileged and hungry children to prevent cancer later in life. Whether you're looking to celebrate survival, honor a loved one, or simply want to support a worthy cause, the PFC Cancer Ride means something different to everyone.

"I'm a firsthand example of why these funds work, specifically for critical cancer research," said Janelle Morales, Administrative Support Staff Supervisor at Moffit Cancer Center. She joined the PFC Cancer Ride for the first-time last year to commemorate her personal journey as a cancer survivor, which she attributes in part to drug research being done at Moffitt, and to honor the memory of her aunt who passed away from the disease.

Dr. Nagi Kumar, Senior Member of Cancer Epidemiology at Moffitt, and teams of researchers so far have identified six specific agents derived from phytochemicals that they are using to develop cancer-fighting drugs for patients, like Morales, in pre-cancerous and early stages of cancer.

"This is an area that is high risk, but also high reward. This work doesn't get funded immediately by the government and other agencies until we have definitive proof, and almost all of them are now," said Dr. Kumar. "But, in the beginning, organizations like Pan-Florida Challenge helped with seed money for the preliminary work testing compounds derived from plants."

David McAllister, his wife, brother, and sister-in-law are self-proclaimed serial fundraisers and passionate cyclists from Jacksonville who also joined the PFC Cancer Ride last year. "The PFC Cancer Ride combined some of our favorite things like cycling in a warm place, fundraising for cancer prevention, and nutrition, which we're all involved in healthy lifestyles and believe is an important component of cancer prevention." The team, known as Angelina's Song, rides in support of dear friends who lost their daughter to cancer in 2015 and started a charity related to music therapy for pediatric cancer patients.

The McAllister's have become friends with fellow riders and say the event is a "tremendous amount of fun." They plan to do their 2023 PFC ride in Tampa. "We're looking forward to it. It gives everybody an opportunity to get involved in a charity that is both worthwhile and mission oriented. We try to come up with unique ways to meet the fundraising minimum, and this year we went to one of my friends who owns Subaru of Jacksonville. They sponsored us, covered our expenses, and they promoted it within their social network. We magnified our efforts by finding a sponsor," said McAllister.

Master Sergeant James Douglas is retired after 26 years in the Army

and is now a JROTC instructor at a local high school. "I like supporting different organizations but coincidentally one of my coworkers had cancer and actually died about three weeks before the ride last year. It gave me even more reason to support the mission," said Douglas. "I also have a friend whose wife just passed away from cancer a couple of weeks ago and I have a family member who now has cancer. So, this is something I can see always doing from here on out to try and help make a difference."

Douglas rode by himself last year but says he quickly made new friends. "The meet and greet before the ride was amazing. Overall, it was just an amazing ride. I believe everyone should get involved with PFC because with every organization, the financial side will always be there. Social media, that's the thing of today and that's probably one of the best ways to actually get out there to help with fundraising. Unfortunately, cancer is not going away and there's no definite cure. so the more awareness the better so that we can bring a cure to this disease and help prevent untimely deaths."

"I am so amazed," said Dr. Kumar. "These riders are just as dedicated as we are, training and giving of themselves physically to this cause. I am blown away by their commitment and I feel like they're definitely a part of our team," said Dr. Kumar.

"We all have been affected by cancer or will be in some way and you can help make a difference," said Jeri Goetz, Executive Director of the Pan Florida Challenge Cancer Ride. "It's a great ride to participate in as an individual or if you get friends together and join a team. It's a ride and not a race, so March 25 – 26, cyclists of all ages and abilities are welcome to join in and choose from multiple routes in Tampa and Naples."

Help! My Pet Has Giardia?

WHAT IS GIARDIA?

Giardia (pictured) is currently one of the most common causes of diarrhea in our area. At Just 4 Pets Wellness Center, we diagnose it multiple times a week. It is rapidly becoming common in our area. Giardia is not a typical "worm" parasite. It is a microscopic, protozoal parasite. It lives and grows in the bowels of humans and pets. When the numbers get high enough, it typically sends waves of cysts (their version of eggs) outside of the body, usually in the form of loose stool or diarrhea.

HOW DO PETS GET IT?

Animals (and people) who encounter contaminated stool or stool particles, become infected when they ingest the cysts. Giardia is not transmitted through blood or urine.

Exposures occur when giardia cysts are picked up from surfaces and objects that contain traces of stool from an infected animal (ie. Bathroom handles, changing tables, pet toys, pet bowls, kisses from your pet, and not washing hands after handling pets or after cleaning up poop outside or in litter boxes). Once exposed, the giardia cysts are ingested, and the infection develops inside of the intestinal tract.

Other sources of potential exposure include: dog parks /beaches, day-care and boarding facilities; drinking water sources where Giardia may live (rivers, lakes, streams or wells), traveling to countries where giardia is common, keeping your pet in a wet environment, not picking infected stools up completely and daily or not cleaning litterboxes daily and disinfecting them regularly.

HOW WILL I KNOW MY PET HAS GIARDIA?

Symptoms may vary. But the most common sign is soft stool or diarrhea. This symptom can come and go. It can be accompanied by gas, abdominal cramps, upset stomach, nausea and vomiting. Dehydration and unexplained weight loss are also common. In puppies and kittens, severe giardiasis might slow development and cause malnutrition and stunting of growth. **HOW IS IT TREATED?**

Giardia can be treated with prescription medications, which typically is administered for 10 days or more. Sometimes this treatment must be repeated in stubborn cases of giardia. Young pets may harbor the organism and keep reinfecting themselves and others around them for up to a year or more.

HOW CAN I PREVENT THIS PARASITE?

Giardia thrives in wet environments. It does not survive for long periods of time in dry environments. So, keeping your pet's environment clean and dry will help to eliminate giardia cysts from surviving and reinfecting you and your pets.

Environmental disinfection and good personal hygiene are important to prevent the accidental spread of giardiasis. For best results, thoroughly clean your pet's living and sleeping areas and then ing up yard waste. Picking up all stools promptly, daily doggie or kitty tushie-wiping and refraining from allowing

pet kisses will help decrease contamina-

tion and exposure to this parasite.

Student School Assignment Is Changing For The 23-24 School Year - Important Message For Parents/Guardians Of Elementary School Students By Cathleen O'Daniel Morgan, District 7

On February 7, 2023, the School • All incoming Kindergarten stu-Board approved the Superintendent's recommendation to adopt the 2023-24 Student Enrollment Plan. The new plan represents a significant change from previous plans built on a primary zone and subzone model.

WHY?

The previous plan has become unwieldy and inefficient. It was implemented in 2005 when the District had 68,000 students. Today, we enroll nearly 100,000 students and continue to grow. The 2023-24 Student Enrollment Plan and future enrollment plans will be based on a proximity zone model intended to reduce the size of attendance zones and decrease the number and length of bus routes.

The new Proximity Plan will be used for enrollment of ALL elementary students. In the new attendance zones, families will be able to choose from between three to six elementary schools, with the exception of the Barrier Islands. You can view a map of the proximity zones and use the interactive tool to search by address on the School District's website.

- dents are required to enroll in a school in their proximity zone. Transportation is provided if they live more than two miles from the school. Incoming Kindergartners may select an out of zone school if an older sibling is already enrolled, but transportation will not be provided.
- Students new the district will be assigned an elementary school according to the proximity zone in which they reside.
- Rising students (grades one through five) who live outside their new attendance zone will be given the opportunity to enroll in a new school within their new zone; if eligible, bus transpiration will be available to their new school. Rising students living outside their new attendance zone and wishingto continue to attend their current school may do so but they must provide their own transportation.

WHO IS NOT AFFECTED?

Rising K-5 elementary students who reside inside their new attendance zone and want to stay in their current school are unaffected and will continue to receive transportation if eligible. All middle and

high school students are unaffected by the new proximity plan in 2023-24. They continue to be enrolled according to the three primary zones and subzone model.

HOW WILL STUDENTS **BE ENROLLED?**

- Families participating in the Proximity Plan (incoming Kindergarten student, elementary students new to the District and those enrolled in schools outside their new zone) must rank the schools within the new Proximity Plan attendance zones in their FOCUS Parent Portal.
- Families desiring to remain in their current school when that school is outside the new Proximity Plan map must affirm they are waiving transportation in their FOCUS Parent Portal.

When the number of applicants for a school exceeds the number of available seats, a lottery process will be used. In the enrollment lottery, sibling preference will be honored.

WHEN WILL ENROLLMENT **BE COMPLETED?**

Open enrollment for elementary schools is from February 13th to

March 10th. Families who do not make an enrollment decision by the end of the enrollment period will be entered automatically in the new Proximity Lottery for a school in their attendance zone. Families will receive information about their school assignment in late March or early April.

HOW AND WHERE CAN FAMILIES GET ADDITIONAL **INFORMATION?**

Every family with children enrolled in a K-5 elementary school will receive messages from the District and from their child's current school. For general information about Elementary Student Enrollment, please go to:



Preventing Tool Theft By Sheriff Carmine Marceno

With the enormous volume of construction and repair being done following Hurricane Ian, the demand

for tools has increased exponentially.

Both professionals and do-it-yourself residents should take a few moments to consider security methods being used to protect their valuable tools from theft. Tool theft is common from both motor vehicles and storage sheds.

Tools stored in vans, pickup trucks

and other commercial vehicles are often seen as easy targets for thieves.

There are a number of options for pickups that include cross-bed boxes, decked bed boxes and custom molded boxes to fit between the truck's rear wheel and tailgate. Two of the most important characteristics seem to be the quality of the locking mechanism and visibility to criminals.

Interior sliding deadbolts have grown in popularity and can be purchased in both manual and electric versions. They appear to be far more difficult to open than standard door lock cylinders. Puck locks offer additional security, especially when dealing with lesser-skilled criminals. Multiple puck locks can be keyed alike so as to allow you to use a single key to open all locks.

Windows are vulnerable points and are often the way vans are broken into. Consider van window grills and dark tint to make the vehicle's contents difficult to see from the outside.

Parking vehicles in well-lit areas often deter would-be criminals. Alarm systems and security cameras should be considered, as well.

Sheds and garages are equally sus-

ceptible to theft. There are a number of affordable shed and garage alarm systems that are wireless and easy to install. Additionally, there are a number of excellent locks that are virtually tamper-proof and designed to protect almost any type of door or entranceway.

The cost of the aforementioned security devices pale in comparison to the cost of tool replacement. While securing your tools and supplies take a few extra moments of your time and may require a bit more effort, consider the cost and time required to replace stolen equipment.

Valerie's House Podcast For Grieving Black Families By Susan Bennett

In honor of Black History Month, Valerie's House has released a special podcast to help Black families grieve the loss of loved ones.

"Black families say they often are left without knowing where to go when they have lost a loved one. We're hoping this podcast will reach into pockets of the community that often don't have a voice," said Valerie's House Founder and CEO Angela Melvin.

Black Americans are three times more likely than White Americans to have two or more family members die by the time they reach age 30, Melvin said.

The current podcast, which began airing February 10, includes two guests who have lost loved ones. Tasheekia Harris, founder of Crowning Daughters for Success as well as the co-founder of Impact Dunbar and a mentor of young boys and girls, gives insight into how she felt after losing her brother.

"Grief is very real. It is not something you can bury. You can only put so much dirt on top of it," Harris says in the podcast. "A lot of distrust, a lot of denial, and the strong men mentality has prevented a lot of the Black community from asking for help."

Teacher Janee Robinson, who also is a Valerie's House mother, is a second guest on the podcast and explains how the loss of her daughter's father made her feel isolated and alone.

"If we don't address self-esteem, we can't work on the grief. Knowing your worth is so important," Robinson says in the podcast. "Asking for help isn't easy, but I'm glad we did." The current Grieve, Love, Heal podcast is the 12th in the Valerie's House series, which was launched in 2019, and can be found on all your favorite podcast apps such as Spotify, Apple Podcasts or on the Valerie's House website. Valerie's House is planning a different topic each quarter on the podcast. Valerie's House has helped more than 2,000 children and their families since its founding in 2016 by Angela Melvin, whose mother Valerie was killed in a car accident in 1987.

Valerie's House currently offers peer support groups and other activities at locations in Fort Myers, Naples, Punta Gorda, Port Charlotte and Pensacola. Valerie's House is a United Way partner agency and is fully supported by community donations.
