A Message From the Lee County Supervisor of Elections

As your Supervisor of Elections, it is my duty to ensure you are well-informed and prepared for all elections. We are now entering the final stretch toward the November 5th General Election, and I would like to provide you with essential information to make sure you have a positive voting experience.

If you have not registered to vote, the deadline is Monday, October 7th. You can register to vote at www.registertovoteflorida.gov.

If you have recently moved, please update your address with our office. As a Lee County voter, it is your responsibility to keep your voter information current, which is crucial when it comes to voting. Your address determines where you vote and the contests that appear on your ballot.

How long has it been since you updated your signature? Whether voting by mail or casting a Provisional Ballot, your signature is critical to ensuring your vote is counted.

Under the Florida Election Code, the signature on your Vote-by-Mail or Provisional Ballot must match the one my office has on file.

Updating is easy—fill out a Florida Voter Registration Application and return it to any Lee County Elections Office. For a list of office locations, visit the Lee County Elections website, LEE.VOTE.

VOTING BY MAIL

If you still need to do so, consider requesting a Vote-by-Mail Ballot. It's the most convenient way to vote and the return postage is paid. Think of it as an insurance

policy against unexpected life events that could prevent you from going to the polls. The hurricane season is not over. Cast your ballot securely, no matter what happens.

The deadline to request a Vote-by-Mail Ballot is 5:00 pm. Thursday, October 24th. Request your Vote-by-Mail Ballot on our website.

EARLY VOTING

I anticipate a high voter turnout for the upcoming November 5th General Election. If you prefer to vote in person, you do not have to wait until Election Day. Take advantage of the Early Voting period, Monday, October 21st, through Saturday, November 2nd.

Early Voting allows you to vote at any of the 12 available locations, open from 10:00 am to 6:00 pm. Visit our website for a list of locations and live wait times.

ELECTION DAY

On Election Day, you can only vote in your assigned precinct. The polls open at 7:00 am and close at 7:00 pm. You must be in line by 7:00 pm to vote!

To save time at the polls, read through and mark your sample ballot before heading out to vote. You can access your sample ballot on the Lee County Elections website.

My staff and I continue to work diligently to protect the security of your vote and ensure that elections in Lee County remain accurate, safe, and transparent. The Supervisor of Elections Office is your trusted source for election information.

The Sand Dollar

As Lee County's Comptroller, I serve as the county's auditor, recorder and custodian of funds. This is a very important part of my job, as I am responsible for managing and investing nearly \$2 billion of Lee County's tax dollars.

Serving as the Comptroller essentially means I am Lee County's Chief Financial Officer. My goal is to promote transparency and shine a light on how your tax dollars are being managed and spent—while also ensuring a system of checks and balances.

A big part of this effort includes the financial report my office produces each year titled The Sand Dollar. It is a free report that can be downloaded at www.leeclerk. org/thesanddollar. I strongly encourage you to read it and learn exactly how your tax dollars are being used. It goes into great detail about Lee County's finances and key economic factors impacting county residents.

The Sand Dollar is an easy-to-read guide that outlines trends in county property taxes, housing, employment, and major construction projects impacting residents. Information about tourism revenue, investments, debt, and Hurricane Ian relief and expenditures are also featured.

It has extremely valuable data on the county's economic and fiscal health, which

has a profound effect on all of our personal bottom lines.

Highlights of this year's The Sand Dollar include:

- During the last fiscal year, the county incurred approximately \$190.7 million in Hurricane Ian-related expenses, received \$71.9 million in stat, and federal grant funds and received \$12.7 million in insurance reimbursements
- Lee County is home to one of the fastest-growing populations in the country, increasing by 24.5% since 2014.
- The median single-family home sales price decreased 3.6% over the last fiscal year while total home sales decreased by 10.5%.
- Property tax collections increased 87.4% over the past decade. In fiscal year 2023, Lee County hit a new record, with more than \$506.6 million in property taxes collected.
- Impact fees grew to \$39,603,671. Impact fees ensure that new developments help pay for the increased transportation, parks, schools, fire protection, and emergency medical services that are needed by that development.

The Principled Philosophy Behind Cryptocurrency

This month marks 16 years since the release of the nine-page Bitcoin Whitepaper (https://bitcoin.org/bitcoin.pdf) and through it the conceptual invention of cryptocurrency. In that time, cryptocurrency has grown from nothing to be worth over \$2 Trillion, following roughly a power-law curve. Most fads unfold differently and last for a shorter time, making cryptocurrency look like a trend. So, you might ask, what drives this? Why does cryptocurrency exist, and why now? Should I do something?

Money and its meaning underpin these questions. Money is a special pervasive good that holds value and can be traded for anything. It endures and can be exchanged over distances. Many types of money have been tried: precious metals, shells, beads, carved stones, cocoa beans, feathers, coins, paper bills, and careful records (on media from clay tablets to computers), to name some. For a form of money to be good, it must be mutually desired and hard to create. People have to want it, and if it is too easy to make more, inflation undermines it as society becomes flooded.

The Bitcoin breakthrough came in 2008 from a still-anonymous person or group going by the name Satoshi Nakamoto. The Whitepaper outlined a new money that was digital for modern needs and hard to duplicate through its very nature. By design, no one can make more than what is prescribed by the system's rules, taking money-creation out of human hands. The technology behind cryptocurrency is quite complex, meriting its own articles and books, but that doesn't matter for a high-level understanding. You just need to know that—when functioning properly—compelling incentives, math, and computer algorithms keep people from making more than is intended.

The other key ingredient of money, that it be wanted, wasn't certain when the Bitcoin Whitepaper was written, but has turned out to be true. Hundreds of millions of people worldwide choose to own it and have given it enormous value. Part of that value comes from speculation, part from utility, and part from principled philosophical appeal.

A cornerstone of cryptocurrency's principled philosophy is that governments should not have the power to create money—that we are better served by separation of money and state, if you will. Today around 160 national currencies exist, all over time suffering inflation from new money creation. Some—like Sudan's—have triple-digit inflation, some—like Egypt's—double-digit, and some—like the US's—single-digit. With time, this takes away almost everything. A dollar bill from 50 years ago holds just 16% of its original value (https://www.usinflationcalculator.com/). If you owned one of those, now it's gone and you're left with just a bad tip.

The Cantillon Effect explains that when a government creates new money, it enriches the privileged close to the government. Value is taken from the people and given to bankers and other powerful government-aligned individuals. This causes strife with obscure origin for the general population, bringing a sense that things are going wrong and they are getting cheated by the rich and well connected. It also funds government warmaking and other harmful actions in ways and to degrees not wanted by the people. Advocates motivated by its principled philosophy see cryptocurrency as a tool to fix this money-creation problem and with it many of society's ills.

A heroic analogy comes from The Lord of the Rings trilogy (movies worth watching based on a book worth reading). In this story, the villain Sauron makes a magi-

cal ring to force his rule over the fictional world called Middle-earth. This evil ring, like the power to arbitrarily create money, corrupts all who come into contact with it. It twists the simplest of folk (Hobbits, in the story), and drives the more sophisticated (Humans, Elves, Dwarves, and others) to crazed evil. Many cryptocurrency advocates see themselves as fighting a similar malevolent force.

And they see this era as special. Governments increasingly apply new technology to surveil citizens, like the growing Eye of Sauron in the story. And with artificial intelligence a government can now manufacture policy-enforcing agents separate from its own citizens, like the story's unnatural mass production of Orc soldiers in pits in Isengard. Permissionless rules-following cryptocurrency resists this pattern and shifts power away from expanding governments. Cryptocurrency advocates tend to believe in limiting centralized authority and strengthening individuals.

To continue the analogy, like the many creature types of Middle-earth, there are now diverse cryptocurrency communities striving for change. CoinMarketCap (https://coinmarketcap.com/) lists thousands of cryptocurrencies, each with its own community. Like the Humans, Elves, Dwarves, Hobbits, and other denizens of Middle-earth, these communities bring different cultures and ideals. Among them lies a place for almost anyone.

A taste of this diversity comes by sampling just three: Bitcoin, Ethereum, and Monero. Bitcoin, as touched on above, was the first, and remains the largest. With a limit of 21 million Bitcoins set to ever exist, its community argues for the soundest possible noninflationary money. The no-frills case for Bitcoin is much like the case for gold. Ethereum, on the other hand, was the first major cryptocurrency to enable general user-created software to execute as part of its core security. This software, called smart contracts, allows purposeful computer processes to be guaranteed to run and automatically move money. The Ethereum community seeks new uses for digital money. The cryptocurrency Monero applies cryptography to hide its own transactions. You cannot just look at the public record and see who owns what or has sent how much to whom. Its community advocates for personal privacy as a fundamental right.

You can see how these example communities differ. The principled philosophy that aligns them, and most of the thousands of other cryptocurrencies, is a belief in finding a better way than traditional government money. And this brings us to where analogy with The Lord of the Rings stops. In the story, the characters know that the evil ring can be destroyed in only one way: in lava in the volcano Mount Doom. In our world, it isn't clear which approach—Bitcoin, Ethereum, Monero, one of the thousands of other cryptocurrencies, or something yet to come—might end government money creation and control. Individual cryptocurrencies can rise and fall while the principled philosophy behind them remains.

Money represents all of life's material goods and more: even glory, vanquishing rivals, and power can often be purchased. The Cantillon Effect tells us we should fix government money as it exists because the wrong people get enormous benefit while others get hurt. How and if we do this forms an important milestone on humanity's winding path ahead, through forests, rivers, and misty mountains. At 16, the cryptocurrency movement is young. If any of these philosophical points resonate with you, you might want to investigate and see if you should follow and encourage it, or even if, like a Lord of the Rings character, you have a personal role to play in the unfolding story.

What To Do—and in What Order—When Your Home Floods

I didn't lose my home, but I lost everything inside when Hurricane Ian flooded it with three feet of filthy canal water and septic waste on September 28, 2022. Walking in the next morning, the smell was overwhelming—dead fish and sewage. My furniture was tossed, and everything below four feet was covered in a greasy, infectious sludge. The wood furniture and cabinets were already warping, and most of my clothes were ruined. I had virtually nothing left.

Despite the devastation, I considered myself lucky—so many lost so much more.

To complicate things, I had just signed a contract to sell the house two weeks earlier. My buyers, who had sold their home and were renting locally, had three options: back out, renegotiate the price, or let me restore the home to its pre-Ian condition. They chose the third option, and we agreed to close on October 31, with the understanding that repairs might not be complete. Thankfully, they loved the home, and by December 14, all repairs were finished.

I learned valuable lessons about flood recovery and saved money by acting quickly. Some neighbors, who waited, had more damage and higher costs due to mold and rot

Here are those lessons. My top advice: ACT NOW, MOURN LATER. The busyness can be therapeutic.

BEFORE A FLOOD THREAT

Stopping several feet of water from entering your home is nearly impossible, so instead, focus on evacuating early. Take yourself, loved ones, pets, critical items (e.g., prescriptions, important documents, valuables), and your vehicles out of the area before the storm hits. This simple step can save your car from flood damage, as many auto insurance policies won't cover vehicles left in a predicted flood zone. Even if insurance covers it, replacement delays can hinder your recovery process.

Be cautious about insurance advocates. While they may seem helpful, ensure you get 7. Set Up a Simple Work Area: A small table and chairs in the garage will be handy for referrals from those with good experiences. Some prefer managing claims directly

without middlemen to avoid added complexity.

AFTER A FLOOD

- 1. Apply for FEMA Help Early: Submit an estimate of your losses as soon as possible since FEMA assistance often operates on a first-come, first-served basis. Even if you have no idea what the total loss is, do your best to guesstimate and apply for help. After receiving funds, avoid further involvement if possible. Stay at your property and monitor the recovery process closely.
- 2. Dry Everything Out: Remove all flood-damaged items (furniture, rugs, papers, etc.) immediately. If the power is not restored within a day or two, rent or buy a gas or diesel-powered generator. Don't try to save anything if the water is dirty. Buy (rent, or borrow) one or more constant-drain dehumidifiers, a hose for each one long enough to reach out through your garage or another suitable, lockable door, and get them running as soon as possible. If/once your A/C is intact and you have power, run the A/C too. Keep the dehumidifiers running throughout the entire process and steps described here. You will be glad you did.
- 3. Start Lining Up Help: Hire help for heavy lifting, teardown, and rebuild. Get references, compare quotes, and break payments into thirds. Act quickly, as contractors and supplies will be in high demand.
- 4. Salvage What You Can: Save reusable items like countertops or fixtures, but replace what's damaged. Some choices will be based on necessity, others on preference.
- 5. Order Supplies Early: Supplies will run out fast, so order critical items like generators, dehumidifiers, bleach, drywall, and any rebuilding materials as soon as possible.
- 6. Clean Out Your Garage: Use it as a staging area for new materials and a secure storage space.

Consider an Electric Vehicle in Your Hurricane Prep

As we head full into the hurricane season, an electrical vehicle (EV) might be a good option in the case of loss of power. There are many reasons why people buy EV's in Florida; fun to drive, reduced maintenance costs, no emissions, etc. One added reason is that an EV can provide backup power in the case of power outages. After Ian, about 98% of the population of Lee County had lost power, with some lasting for days. As we all get ready for hurricane season, here are some aspects to consider for incorporating EV's into your hurricane preparedness plan.

VEHICLE-TO-LOAD (V2L)

For EV's, there are two important technologies to consider; vehicle-to-load (V2L) and vehicle-to-home (V2H). "Having a car that is V2L capable means that you can connect your car's batteries to provide power to appliances, like refrigerators, freezers, fans, etc. With tens of kilowatts of power, most cars can power critical appliances for

VEHICLE-TO-HOME (V2H)

With a V2H capable EV it means that your car can be incorporated directly into your home's power network. In the case of a power outage, your car's batteries provide power to your whole home. If your home or business has the ability to generate power, as when paired with roof-top solar, your home becomes a "micro-grid" with a disconnect until the power is resumed from the utility.

For storm prep, the primary benefit is powering homes during power outages. It is not any different than a generator, except that when combined with solar, V2H EV's can help reduce your utility bill every day, storing solar energy during the day to be used during the night. Generators are only used when the power is out. When comparing the financial investment in a car, the average car usage is ~ 10% of the time, sitting 90% of the time parked. EV's with V2H aren't then used just during a storm, or just to and from work, but all the time.

Utility companies are also becoming interested in V2H, especially as working with customers, the available stored energy helps them manage demand peaks, reducing the investments needed, especially in areas with growing populations like Florida.

DRAWBACKS

Limited Availability—V2L and V2H technology is still new. If you ask your local car salesperson, they tend to look at you like you're speaking another language. Almost

all automotive companies have plans for V2L/V2H, and many have a few models. GM is probably the automotive company currently with the largest variety of available models. Many trucks, like Ford F150, Rivian, and others have V2L available to provide power on worksites. Best to do your homework online before car shopping.

Costs—Chargers for V2L are the same as for a regular EV with options available online or from big box stores like Costco at approximately \$600-800. Bidirectional chargers, which are required for V2H, are more expensive and may require additional electrical equipment, such as a smart meter or a home energy management system. The utility and local permitting rules vary, so best to consult a licensed installer/elec-

TRENDS

Price Reductions—While EV sales have slowed recently, they are becoming more common, and prices, especially for used EVs, are coming down. With the growing interest in V2H, investments are generating innovations that improve efficiencies. One very interesting technological advance is V2H systems that automatically optimize energy usage based on demand and availability.

Utilities/Government/Business Interest—For utilities like FP&L, the availability of V2H basically expands the grid, without them needing to invest. This extra energy helps them manage the demand and improve efficiencies during peak periods, relieving resources needed to manage outages. Schools are seeing the benefits of V2H with school bus fleets as a significant power source in the case of an outage, especially when schools are designated shelters. Any other business with large fleets of vehicles is leveraging the investments as a power source for their operations or part of their resiliency plans.

SUMMARY

EVs with V2L and V2H technology can help Increase energy resilience during power outages. They are a power option for hurricane preparedness. The V2H technology helps to reduce emissions. When combined with rooftop solar, it helps integrate renewable energy into the grid and helps utilities manage the grid more efficiently during power outages. 😩

The Everglade Snail Kite: The Ultimate Comeback Kid!

lacksquare Everglade snail kite would have been at the top of your checklist. I was a young college kid at the time, dabbling in the birding world along with a group of wildlife enthusiasts. We made many trips to the Everglades and Big Cypress National Park hoping to catch of a glimpse of these and other uncommon birds. At that time in 2007, the population of the Everglade snail kite had fallen to less than 800 birds so a sighting of this species would have been rare indeed, and something to celebrate This species, scientific name of Rostrhamus sociabilis plumbeus, has been federally listed as endangered since 1967.

The population decline of this unique raptor was due to several possible causes, but the main cause was believed to be loss and degradation of their natural habitat, wetland areas. Specifically, drainage of the Everglades was believed to be a major cause of their decline. In 2004, the arrival and rapid spread of an exotic apple snail species was feared by biologists to be another threat to the survival of the snail kite. The Everglade snail kite is unique for its specialized diet, it evolved to feed only on native Florida apple snails thanks to a specialized beak, curved at just the right shape and angle to remove the native snails from their shells. Initially, biologists feared that the exotic species of apple snail would be too large for the snail kites to effectively remove and consume, and as the invasive species spread and outcompeted the native snail species, biologists became very concerned for the survival of the snail kite.

However, something completely unexpected happened. The Everglade snail kite population began to increase as the exotic snails increased and spread, instead of declining further. The populations seem to be evolving, with snail kites beginning to have longer beaks which enable them to effectively handle the exotic

Tf you were around South Florida in 2007 and were into birding, a sighting of the 3,000 birds. I have seen the growth of their population firsthand. In 2007, during our many outings, we never achieved a sighting of a snail kite. Two years later in 2009 I caught a few unplanned sightings of them along canals in Lehigh Acres where they hunted their snail prey. Then in 2013-2015 while working on farms all around southwest Florida, I regularly spotted the birds hunting along the irrigation canals and nesting in pockets of wetlands around the farms. Now in 2024 my personal observations of these unique predators have become even more frequent and expanded from the canals and filter marshes of Lehigh to regular sightings of them hunting the ditches along state road 82 and this summer they have been regulars along Daniels Parkway.

> If you would like to catch a sighting of these interesting predators, keep an eye out for them around shallow bodies of water that contain the snails. Some of the best places to see them are ditches, canals, and filter marshes. Harns Marsh in Lehigh Acres is a great place to visit for an almost guaranteed sighting of the kites. Look for a medium-sized raptor gracefully floating in the air low over the water searching for snails, or perched on vegetation near the water watching for their prey. Their nests will be found in trees in the middle of wetlands, where they are protected from predators. The females and juveniles have mottled brown and buff coloration whereas the males are a slate gray. Both males and females have a noticeable white band at the base of the tail that is a striking identification characteristic.

> To support the continued growth of their population, we must support efforts to preserve and restore wetland areas while protecting the water quality in wetlands. With any luck, the combination of those efforts with the snail kite's consumption of the invasive apple snail might start to assist in the recovery of the populations of our native apple snails as well. 🗳

Cultivating Leadership: My Experience in 4-H

Tjoined the Goats R Us 4-H Club (now known as Alva Livestock 4-H Club) as a Cloverbud when I was 5. It was then that I first experienced the magic of 4-H. It was somewhere I always felt I "fit in" and could balance my love for animals, making friends, and learning about leadership and other life skills. When I became a Senior member, I joined a second club, Lee County Teen Leadership 4-H Club, where I continued to grow and learn new life skills.

Just Say, "No!" to Clusia Hedges

Ilusia hedges have been popping up all over the area in recent years. People seem to be happy with them, so what's the problem?

The problem is that we can do so much better!

First, hedges of a single species are always an issue if a pathogen or invasive insect attacks it. Your entire hedge could be gone, leaving you feeling rather exposed. A better decision is to plant a hedgerow of mixed species. They can be grouped by species or by repeating a planting pattern.

Next, the clusia hedges that are being planted are not Florida native plants. Many landscapers think they are native and might even tell you so. They are wrong. They are simply readily available, cheap plants that provide little to no value to our native wildlife.

There is a clusia (Clusia rosea) that is native to Florida, but that one is rarely used in a hedgerow and seldom planted. Most landscapers likely are not familiar with

Furthermore, the non-native clusia hedges do not hold up well during hurricanes and are susceptible to breakage. Not only that, but they are generally trimmed with hedge trimmers that cut the thick leaves. It's not the best look.

Finally, there are too many fabulous native plants that will look better and pro-

or part sun. When they bloom, they attract a variety of pollinators. Then, once the blooms turn to berries, birds and other wildlife flock to the shrubs. Best of all, Spanish stoppers are rather slender and generally only grow to 8-10 feet tall. That means they can be minimally trimmed, which saves you money! They are beautiful and they hold up well in hurricanes.

Shiny leaf wild coffee or Psychotria nervosa are great for shadier locations. They grow 4-8 feet tall as they produce flowers for pollinators such as atala, great southern white, Julia and other butterflies. Many other pollinators love them as well. The long-lasting berries are adored by mockingbirds and more.

Peppering in the native firebush or Hamelia patens var. patens could bring hummingbirds and more. Just make sure you get the native firebush that stays much smaller than the "dwarf" that grows to about 18 feet!

Adding a native hedge will provide so much more benefit to the environment over a non-native hedge. The flowers and fruits will bring an assortment of insects and creatures that support the local food chain. There are more options than we have space in this column.

If you are thinking about adding a hedge, ask your landscaper to use Florida native plants and don't settle for clusia. Consult your local native nurseries for more information or visit The Coccoloba Chapter of the Florida Native Plant Society's website at www.FNPSCoccoloba.org. 😩

The applicant has/currently owned mining operations in the past at which they received numerous code enforcement violations which led to the mine being shut down (this is Crescent Acres in Glades County). Code enforcement violations included damage to the roadway, dump trucks traveling at high rates of speed, operating outside of County noise ordinances and ignoring the stipulations of the agreement with the county.

The subject property is located less than 700 feet to the east and less than a half mile to the west of two Hendry County bus stops, which pick up our youth at 6:12 am and 6:16 am, respectively.

In addition, this property owner has illegally mined this exact property and the only reason they are applying for a rezone is in response to their code enforcement violations as stated in the LPA packet.

Residents near this property also fear for environmental impacts as well. According to the LPA packet, it is stated that there will be NO wildlife implications as well as NO drainage implications. The dirt that will be mined off of this property will cause the surrounding swampy properties to drain south, flooding several property owners as well as CR 78. Panther sightings have been noted in years past in this area by the Florida Wildlife Commission, as well as a large gopher tortoise population in the surrounding areas.

Beware of QR Code Scams

R Codes, "Quick Response Codes," are all around us. These square, black and white boxes allow businesses to quickly direct you to their web site, can track product information in a supply chain, link us to applications as well as store financial information. The uses for these codes are nearly limitless as they store a great deal of data in a very small space.

Our smartphones scan the pattern simply by pointing the phone's camera at the code.

As is often the case, criminals and scammers find methods to steal personal data and money using these very same technologies.

Nationwide, law enforcement agencies are receiving numerous calls regarding altered QR Codes designed to illegally obtain a victim's banking information, credit card information and/or personal data stored on their smartphone.

Scammers are always searching for ways to separate you from your money and they have discovered that the use of fraudulent QR Codes is an effective way to


For example, QR Code scams involving parking fees have been reported across the nation. "Scan to Pay" stickers are placed on parking meters and around public parking locations. Most of us are in a hurry to get to our destination and pay little attention to where our parking fees are being sent.

Many reports have been received regarding fraudulent discount coupons being sent via email or text messaging. By copying a legitimate ad from a reputable retailer, scammers then cut and paste their QR Code over the legitimate one. By doing so, you are redirected to a phishing website capable of stealing credit card and personal information.

Please consider the following methods of prevention:

- Do not scan a randomly found QR Code. Be selective!
- Look for QR Code tampering such a sticker placed over an existing QR Code. Some scammers are physically pasting bogus codes over legitimate ones. If it looks as though a code has been tampered with at your local bar or restaurant, don't use it. This applies to legitimate ads you obtain or receive in the mail.
- Be suspicious if, after scanning a QR Code, the site asks for a password or login info.
- Do not scan QR Codes received in emails unless you know they are legitimate. Call the sender to confirm.
- Carefully review the destination page.

Should you be victimized by a fraudulent QR Code, please contact the FBI's Internet Crime Complaint Center at www.ic3.gov or call your FBI local office. Fraud can also be reported to the Federal Trade Commission by visiting www.reportfraud.ftc.gov. 😩


